### Other Site Characteristics

1.1 Situation Le site au sud-est de Grosbous comprend une Hêtraie entourée de prairies permanentes et de végétation arbustive. 1.2 Milieu physique Le substrat géologique est formé par le grès bigarré du système triasique. Les sols sablo-limoneux et limoneux, non gleyifiés à modérément gleyifiés couvre la partie centrale de la zone, les sols argilo-caillouteux à charge dolomitique, non gleyifiés, à horizon B structural les extrémités à l'ouest et à l'est. Au nord du site on trouve des sols sablo-limoneux et limoneux, fortement à très fortement gleyifiés. 1.3 Occupation du sol Les prairies permanentes, qui forment pratiquement la totalité des terres agricoles, occupent 51% du site. Le reste de la surface est occupé par des forêts et des milieux semi-naturel (9 ha). Les forêts sont formées à presque 97% par la Hêtraie à mélèze et aspérule.
