Summary of test results*

The product was found to contain $0.0010 \pm 0.0002^*$ g/100 g of free formaldehyde. The permitted concentration of 0.00005% by weight was thus exceeded for the sample submitted. The sample does not comply with the requirements of Article 67 in conjunction with Annex XVII, entry 75, column 2, paragraph 1(a) of Regulation (EC) No 1907/2006. The sample therefore may not be placed on the market for tattooing purposes and may not be used for tattooing purposes.

Risk description (technical defect and consequences)*

Formaldehyde with the abovementioned content was detected in the sample. Formaldehyde is classified as a Category 1B carcinogen and may not be used in mixtures for tattooing purposes in the detected concentration.
